Supervisor Obligations:

Banting PDF Awards are administered by the Canadian Institutes of Health Research (CIHR) and are paid out as a stipend-type of award to the host institution. If awarded, it will only cover the salary and not the benefits cost of the PDF (*i.e.* benefits are an ineligible expenditure under Banting). Benefits are estimated at 18% of the salary, or \$12,600 per year for 2 years and must be covered by other eligible sources.

I understand that Banting Postdoctoral Fellowship LOIs require a commitment to provide benefits payments if the candidate is successful in receiving the award, and that I will need to provide a cost-centre with sufficient funds to YSGPS before the application is submitted to Banting Canada.
