

## Introduction

The Ryerson Centre for Immigration and Settlement (RCIS) is now in its 3<sup>rd</sup> year of operation. It was established by Ryerson Senate in March 2011 and opened its doors in July of the same year. The overall goal of RCIS is to advance policy-related research and scholarship in the areas of immigration and settlement, both nationally and internationally.

RCIS continues to draw on a strong research and teaching presence related to immigration and settlement studies at Ryerson. In particular, Ryerson launched the interdisciplinary Graduate Program in Immigration and Settlement Studies (ISS) in 2004, and the interdisciplinary PhD Program in Policy Studies with a field of specialization in Immigration, Settlement, and Diaspora Policies in 2009. RCIS's research focus complements these graduate teaching programs.

This report reflects on RCIS's activities in 2013-2014. Highlights include:

- The start of the SSHRC-funded partnership development project "Integration Trajectories of Immigrant Families".
- The launch of the "RBC Immigrant, Diversity and Integration Project".
- The introduction of the RCIS Working Paper Series.

The remainder of this report summarizes in greater detail RCIS's activities and accomplishments, evaluates these activities vis-à-vis RCIS's strategic planning objectives, and outlines future activities and strategic planning.

## **Governance & Affiliates**

RCIS continues to implement the governance and administrative structure outlined in the founding document passed by Ryerson Senate. The 2013-2014 RCIS Advisory Committee consisted of three members from the Faculty of Arts and three members from the Faculty of Community Services, two student representatives (one from the Policy Studies PhD Program and one from the ISS Program), and the Academic Director, Harald Bauder (Appendix A).

The number of **RCIS Affiliates** has grown to an impressive 46 Ryerson faculty members (Appendix B). Recruitment efforts by RCIS are increasingly successful in attracting affiliates from not only the Faculty of Arts and the Faculty of Community Services, but also the Faculty of Communication & Design, the Ted Rogers School of Management, the School of Fashion, and the School of Urban and Regional Planning. Thus, RCIS is establishing a campus-wide community of immigration and settlement researchers.



#### Research

RCIS successfully applied for Tri-Council funding and is administering (with the Diversity Institute) a research grant competition and internship program funded by the Royal Bank of Canada.

## **Research Projects and Funding**

SSHRC Partnership Development Grant (2013-2016), "Integration Trajectories of Immigrant Families", PI: Harald Bauder, total value: \$153,636 (2013-2014 value: \$50,762). To date, literature reviews have been conducted on the following sub themes:

# **Outlook & Strategic Planning**

This section evaluates RCIS' activities and accomplishments in relation to the *RCIS Strategic Plan*, *2012-2016*. This plan's 6 objectives and 8 concrete strategies are aligned with RCIS's founding document and Ryerson University's planning document *Shaping Our Future: Academic Plan for 2008-2013*.

# **Objective 1: Scholarly, Research and Creative Activities (SRC)**

RCIS has been very successful in conducting and promoting SRC activities among the Ryerson community. An important milestone was the successful launch of the *RCIS Working Paper Series*. In addition, several literature reviews have been conducted in the context of the SSHRC-funded project "Integration Trajectories of Immigrant Families" and will be made available soon as *RCIS Working Papers*. Furthermore, the launch of the "RBC Immigrant, Diversity and Inclusion Project" marks an important breakthrough in enhancing research productivity and capacity at Ryerson.

• Recommendation: Continue to conduct high-caliber research, pursue external funding sources, and engage potential sponsors.

RCIS has deepened and expanded important research and knowledge mobilization partnerships in the context of the partnership development project "Integration Trajectories of Immigrant Families". In addition, it continues to collaborate successfully with national and local partners to co-sponsor and/or co-organize events, and is developing international partnerships. RCIS is also represented on the CERIS Management Board.

 Recommendation: Continue deepening and expanding productive research partnerships and networks at local, national, and international scales, and enhance organizing and sponsoring events with collaborating organizations.



## **Objective 2: Student Engagement**

RCIS has an excellent track-record of involving students in research, knowledge mobilization activities, and administration. In the past year, it significantly accelerated student involvement. In addition to two PhD-level coordinator positions, RCIS hired seven graduate student research assistants, and offered a graduate-level student placement position and a Ph.D.-level fellowship. In addition, RCIS successfully applied for and filled one undergraduate Work Study position.

• Recommendation: Continue involving students in research and administration. Develop an RCIS-MCI postdoctoral fellowship.

## **Objective 3: Research and Learning Environment**

RCIS is located in an office on the 6<sup>th</sup> floor of Jorgenson Hall; it has also been able to temporarily use a small office on this floor to accommodate visitors. Although this space has enabled RCIS to sustain its operations, it is ineffective in fostering meaningful and stimulating interaction between RCIS affiliates and students.

In addition, space is extremely tight. The RCIS Coordinator, Project Coordinator, research assistants, fellows, and Work Studies student have all been located in a single office. In addition, the RCIS office is also used by the ISS placement officer, Farishta Dinshaw. While shared RCIS and ISS space is highly desirable, more space should be made available.

 Recommendation: Secure centrally-located permanent space to be shared with ISS and Policy Studies students and staff to create an effective research, learning, and creative environment.

# **Objective 4: Funding**

With successful SSHRC grant applications and the commencement of the RBC Immigrant, Diversity and Inclusion Project, RCIS is establishing a solid funding track-record. However, RCIS in not receiving any overhead funds from these grants. Thus, increased operating expenses and administrative work resulting from research administration, is not matched with a commensurate increase in funding. Furthermore, the funding RCIS receives from the Offices of the Provost, the Dean of Arts, and the Dean of Community Services is incrementally reduced every year (see attached Funds Transfer Summary). The combination of these factors creates a situation of increasing operating and administrative expenses but decreasing revenue flows. Although RCIS has temporarily been able to carry funds forward from past surplus-generating activities, RCIS will not be sustainable at current funding levels.

- Recommendation: Increase base-funding to cover basic operating and administrative expenses.
- Recommendation: With the increasing representation of affiliates from across campus, it may be appropriate for faculties and units other than the Faculty of Arts, the Faculty of Community Services, and the Office of the Provost to contribute to base-funding.
- Recommendation: Identify funding from private foundations and/or sponsors to ensure financial sustainability.

The budget of RCIS's founding document passed by Ryerson Senate states that the responsibility to raise funds from other sources "requires broader discussion between the Deans and VPRI and the Provost concerning the distribution of grant overheads. Any shortfall will be funded by the Deans of Arts and Community Services in the same proportion as the distribution of the overheads."

Recommendation: Transfer a portion of grant overheads to RCIS.

The RCIS founding document passed by Ryerson Senate in 2011 lists as the first "Activity" to "Establish an endowed Research Chair in Immigration and Settlement". This activity has not yet been pursued:

• Recommendation: The Offices of the VP, Research and Innovation and VP, University Advancement should work closely with RCIS to raise funds required for this endowed chair.

## **Objective 5: Administration and Governance**

RCIS has an effective governance and management structure. The current RCIS Advisory Committee equally represents the Faculty of Arts and the Faculty of Community Services, as well as students in the ISS and Policy Studies PhD programs.

• Recommendation: Expand the RCIS Advisory Committee to include community representation.

# **Objective 6: Reputation**

RCIS's research activities, events, exposure in mainstream and ethnic media, the active participation in social media, and sustained engagement in the settlement community continue to enhance the reputation of RCIS and Ryerson University. The locally-relevant and applied nature of RCIS events has contributed to Ryerson's role as a City Builder, and partnerships and collaborations in organizing these events have been extraordinarily effective in expanding RCIS's communication network. In addition, RCIS is establishing an international reputation through international partnerships, hosting international visitors, and social media engagement.



• Recommendation: Continue organizing high-profile events, engaging with media, participating in social media, and fostering local, national, and international collaborations.

Research expertise: newcomer children, youth, and families; parent–teacher relations; preparation of teachers to work with diverse populations.

Research expertise: the security state and securitization; the post-colonial state; capitalist globalism and international development; political and militant Islam; comparative study of multiculturalism, nationalism, and issues of South Asian state and society.

**Joan Andrew:** Public Servant in Residence in the Department of Politics and Public Administration, and former Deputy Minister of Citizenship and Immigration in Ontario (2005 to 2009). She has worked within government on immigration policy, employment equity, women's issues and labour market policy.

**Sedef Arat-Koc:** Associate Professor in the Department of Politics and Public Administration. Research Expertise: Canadian immigration policy, specifically policies affecting immigrant women; multiculturalism and racism; imperialism; Turkish state and



society in the context of neoliberalism and post-Cold War geopolitics.

**Cynthia Ashperger:** Associate Professor and Director of the Acting Program at Ryerson Theatre School. Research expertise: acting training, theatre and exile. She is working with issues of the audible minority as they relate to representation in theatre, film and radio and TV.

**Idil Atak:** Assistant professor in the Department of Criminal Justice and Criminology. Research expertise: irregular migration and human rights, refugee protection in Canada and in Europe, securitization, international and European immigration and human rights law.

**Rupa Banerjee:** Assistant Professor of Human Resources and Organizational Behaviour at Ted Rogers School of Management.
