

Refugees' Social Mobility and Cultural Bias in the Polarization of Reality

Refugees' cultural values and perceptions are bound to change over time as a function of their new acquired identity and experiences in the recipient country. The current study questions how social-mobility success in the recipient country affects the polarization of happiness levels and political views of refugees.

We reinterpret this research, looking at the endogeneity of the perception of reality by migrants, in particular young Syrian refugees. We focus on two sub-aspect of the polarization of perception question: (i) the endogeneity (i.e. dependence) of perceptions (and their change over time) in relation to the social-mobility success by the young refugees in the recipient country, using information on the refugee's parental occupational status; (ii) the impact from socio-economic mobility on the individual's happiness levels, their cultural integration and political perceptions.

To conduct the above research, we use a novel IAB dataset on Syrian refugees in Germany. The data includes the evolution of educational success, social mobility, happiness levels, cultural values, and political perceptions of refugees between 18 and 35 years of age. The data covers annual survey waves for the period 2016 – 2020, with pre and post COVID-19 information. We employ a Heckman selection model, using a Mincer equation (including effort to learn German) to explain the pre-selection into success in social-mobility upon arrival in the recipient country. We study how this pre-selection affects three alternative hedonic model outcomes: the refugee's individual happiness, their cultural integration (approximated through the level of cultural value change in the direction of increased cultural proximity with the recipient country's milieu) and the perceptions about the political economy in this country.

Our findings help distinguish the impact from personal effort and personal drive for perceived belonging and well-being. These results are representative for young Syrian refugee population in Germany, however the revealed mechanisms of social-mobility-based perceptions and integration might be worth exploration also in other countries.
