WHAT IS THE RULE OF LAW PROJECT?

It is an initiative of a group of Canadian lawyers and academics to reinforce our professional commitment to the Rule of Law in Canada.

HOW DID THE PROJECT START?

Senior lawyer Sandra Barton rallied a group of concerned lawyers and academics, who want to educate the public about the important role the rule of law plays in our democracy, and to encourage lawyers and others to stand up for the rule of law so that it does not get eroded over time.

WHAT ARE THE PROJECT'S GOALS?

The Rule of Law Project Canada is dedicated to creating a community of lawyers that will work together to support the rule of law. We welcome lawyers from all areas of practice. We will strive to educate all Canadians on the importance of the rule of law.

We created a simple **Rule of Law Pledge** for lawyers.

WHAT IS THE PLEDGE?

The Pledge is a “renewal of our vows.”

When we become lawyers, we take an oath to support the administration of justice and the rule of law.

BARRISTER AND SOLICITOR OATH FOR ONTARIO

...I shall protect and defend the rights and interests of such persons as may employ me. I shall conduct all cases faithfully and to the best of my ability. I shall neglect no one's interest and shall faithfully serve and diligently represent the best interests of my client. I shall not refuse causes of complaint reasonably founded, nor shall I promote suits upon frivolous pretences...

BARRISTER AND SOLICITOR OATH FOR ONTARIO

...I shall not pervert the law to favour or prejudice any one, but in all things I shall conduct myself honestly and with integrity and civility. I shall seek to ensure access to justice and access to legal services. I shall seek to improve the administration of justice. **I shall champion the rule of law and safeguard the rights and freedoms of all persons.** I shall strictly observe and uphold the ethical standards that govern my profession...

THE RULE OF LAW PLEDGE



Protection of the judicial system

We affirm our obligation to encourage respect for the administration of justice, and commit to protecting the Canadian judicial system and all of its participants from undue interference of any kind.



Legal work supporting the rule of law

We will seek to ensure access to justice for litigants where the rule of law in Canada is at stake, including through pro bono work where necessary.



An attack on one is an attack on all

We commit to supporting members of this Coalition of Canadian Lawyers in their work to uphold the principles in this document. If any coalition member becomes subject to undue harm or interference by any arm of any Canadian government as a result of its efforts to uphold the above principles, we all commit to supporting that member's resistance efforts.
