

MASTER'S RESEARCH PAPER and SUPERVISOR AGREEMENT

ECS graduate students who have chosen the MRP program option must submit this form, with all the required signatures to the Program Office. Deadlines: Full time students - no later than the end of the 2nd term (end of Winter), Part time students - no later than the 4th term (end of Fall). Students and supervisors are to update to the Plan of Study form. Supervisors take on the responsibilities of the advisor for the remainder of the student's time in the program. Students are to familiarize themselves with the MAECS MRP Guidelines.

If applicable, the supervisor will review and advise the student on the university's research ethics protocol and the Online Ethics Protocol Submission and Review process.

Registration and completion of the Tri-Council Policy Statement (TCPS) online tutorial is a requirement for all graduate students. Graduate students must complete the tutorial before submission of the online application for ethics approval.
