Faculty members are entitled to receive \$8,300 if they are assigned a voluntary overload of a one semester course that is three (3) hours long. This \$8,300 stipend may be prorated (for shared teaching arrangements, for teaching part of a course as a replacement; and/or if overload teaching semester hours exceed three (3)).

CUPE Local 3904 Unit 1 Contract Lecturers are entitled to receive \$7,000 if they are assigned a voluntary paid overload teaching of a one semester course that is three (3) hours long, and may be prorated accordingly if less than three (3) semester hours.

Faculty members teaching voluntary overload in CE, are issued a contract at the prevailing CUPE Local 3904 Unit 2 pay rate. Only overloads in an interdisciplinary program in YSGPS require approval from the Vice-Provost and Dean, YSGPS as well as consultation with, and approval from, the faculty member's home Faculty Dean.
