# The Launch of the BMO Newcomer Workforce Integration Lab

The BMO Newcomer Workforce Integration Lab was officially launched on May 8, 2024, marking a groundbreaking step in addressing the employment challenges faced by newcomers to Canada. Housed at Toronto Metropolitan University (TMU), the lab was made possible by a generous \$3 million donation from BMO Financial Group to support the Labour Market Migration in the 21st Century research pillar of the Canada Excellence Research Chair (CERC) in Migration and Integration. This collaboration bridges the gap between evidence-based academic research and employer practices in the corporate sector, fostering a unique partnership that combines rigorous scholarly insights with real-world application. By aligning the expertise of TMU's research teams with the practical needs of employers, the lab is poised to generate innovative solutions that are both impactful and actionable.

The lab focuses on addressing systemic barriers, leveraging innovative technology and AI tools and sharing evidence-based strategies to empower employers in hiring skilled immigrants, while supporting newcomers to thrive within Canada's labour market. By combining TMU's world-class research expertise with BMO's deep-rooted commitment to diversity and inclusion, this partnership seeks to unlock the full potential of newcomers—driving benefits for individuals, businesses and the broader Canadian economy. This transformative initiative advances the workforce integration of newcomers and highlights the strength of collaboration between academia and industry in fostering inclusive and sustainable economic growth.

The May launch event—which kicked off the CERC's annual Migration Disrupted Conference—brought together a distinguished group of attendees to celebrate BMO's generous donation, and underscored the significance of the BMO Newcomer Workforce Integration Lab. Among the prominent guests were senior BMO executives, including Helen Siebel (Head, Community and Employee Giving) and Alexandra Soares (Strategic Talent Acquisition and People & Culture Leader), alongside TMU leadership, including Dr. Mohamed Lachemi (President and Vice-Chancellor), Dr. Anna Triandafyllidou (Canada Excellence Research Chair in Migration and Integration), and Dr. Steven Liss (Vice-President of Research and Innovation).

At the top of the day, Helen Siebel made remarks on behalf of BMO, and Dr. Marshia Akbar, the Director of the BMO Lab, also played a central role in the proceedings. Additionally, the event welcomed more than 200 leading researchers, academics and practitioners specializing in migration and integration, showcasing the breadth of expertise and collaboration, and the CERC's important role in fostering dialogue and partnership within the field.



# **Webpage Development**

Hosted on the TMU website, the new BMO Newcomer Workforce Integration Lab webpage serves as a comprehensive hub for information about the lab's objectives and activities. These initiatives demonstrate the lab's commitment to producing actionable research and fostering practical solutions that focus on diverse labour migration themes. With its dual role as an information and dissemination platform, the webpage will ensure that the lab's outputs are accessible to a diverse audience, contributing to the development of an inclusive and sustainable labour market in Canada. 
- Hiring Practices and Workplace Integration, with a particular emphasis on technology-related barriers, including the implications of AI tools in recruitment; and
