### Ryerson University President's Update to the Board of Governors November 25, 2013



Everyone Makes a Mark

**Star Blanket** – On October 25th the university gave pride of place to the traditional star blanket given as a gift to Ryerson from the Aboriginal Education Council in 2010. The elegant blanket, hand-made in Ryerson blue and gold, is on permanent display in the main hallway of Jorgenson Hall, celebrating the history and culture of our community.

RBC support for inclusion – On November 13th Ryerson was honoured to welcome Board Vice-Chair Janice Fukakusa and colleagues for the announcement of \$1.75 million in support of the RBC Immigrant Diversity and Inclusion Project. Four key areas – immigrant employment and entrepreneurship, social engagement, mental health, and consumer behaviors – will engage Ryerson faculty and students in multidisciplinary approaches advancing understanding of the challenges facing immigrant populations and providing better opportunities for their success. The project builds on an eminent record of RBC leadership partnering with Ryerson in areas of academic strength contributing to social progress at local and global levels.

Partnership with St. Michael's Hospital – On November 6th, Ryerson and St. Michael's Hospital announced a 20-year partnership on a new Institute for Biomedical Engineering and Science Technology (iBest). A key part of the initiative is the creation of a 22,000-square-foot home in St. Michael's Keenan Research Centre for approximately 15 Ryerson faculty members and 40 Ryerson students involved in ongoing health care research. The space will also include a 2,000-square-foot "incubator" that will specialize in the development and commercialization of innovative biomechanical products to care for and treat patients, similar to the Digital Media Zone. A new connection to the hospital via a bridge over the institutions' common street will also allow researchers to apply their discoveries to patient needs in "bench-to-bedside" research. Construction is expected to start next spring, with move-in spring 2015.

\$3 million research grant – A project exploring "new ways to reduce the stigma of mental illness among men and boys in Asian communities" has been awarded \$3 million over three years by the Movember Foundation. Led by principal investigator Dr. Sepali Guruge, Daphne Cockwell School of Nursing, the project will study the effectiveness of two pilot anti-stigma interventions with 2,160 men living in Vancouver, Calgary and Toronto. Co-principal investigators are Ryerson nursing professors Josephine Wong and Souraya Sidani, partnering with colleagues from the Centre for Addiction and Mental Health, the University Health Network, Simon Fraser University and the University of Calgary, as well as community-based agencies providing culturally and linguistically inclusive social care across Canada.

**Reputation Rankings** – In both the *Canadian Business* and *Maclean's* magazine ranking issues, Ryerson gets a very strong rating among professionals surveyed for the reputation category and asked which school impressed them most highly. In *Canadian Business*, Ryerson joined leaders including Western, the University of Toronto, McGill and UBC on the Top 10 list at #10; in *Maclean's*, out of 49 universities included in the ranking issue, opinion-makers chose Ryerson as #11 in the country for "Most Innovative" and #7 nationwide in "Leaders of Tomorrow."

**Next Big Idea** – Winners of 'The Next Big Idea' competition for India's most innovative entrepreneurs were announced on November 11th: *Citrus Payment Solutions*, an online system for merchants and consumers, and *Ingenuity Ventures*, a marketing service using interactive media and social networking, have won the opportunity to experience three weeks incubating their businesses in the DMZ. Supported by the Ontario government, this is the first activity associated with the partnership launched between Ryerson University, Ryerson Futures Inc. (RFI) and Bombay Stock Exchange Institute Ltd. (BSEI) in July 2013.

**DMZ International Fellows** – This term four young entrepreneurs have joined Ryerson from the Communication University of China in Beijing, staying with us until the end of December to work on their start-up ideas, collaborate and learn, and experience Canadian culture firsthand. Their projects include applying post-graduate work in cloud innovation technology to the travel industry; advancing PhD work on signal processing to the field of 3D audio/video-sharing; user interactivity connecting people to the digital world using smart devices; and focusing master's studies in communication and journalism on new media technology content for commuters.

**Remembrance Day** - On November 11th Ryerson joined Canadians from coast to coast in honouring the sacrifices of veterans of past wars, and the many who serve in modern-day operations around the world. The occasion to pause and reflect is engaging more people every year as a significant event in our community calendar. Ryerson also hosts the Annual Black Veterans Remembrance Ceremony recognizing the contributions of Canadian Forces who served overseas and participated on the home front as fundraisers, factory workers, and volunteers.

Two city-building awards – Heritage Toronto has recognized the partnership of Ryerson University and Loblaw Companies Limited, and project architects and contractors, with the 2013 William Greer Architectural Conservation and Craftsmanship Award of Merit for exceptional preservation and craftsmanship in the restoration of Maple Leaf Gardens. On November 14th a historic plaque will be installed by Heritage Toronto at the site. As well, Tourism Toronto and the Greater Toronto Hotel Association (GTHA) have presented Ryerson with the 2013 Presidents' Award for "preserving Toronto's past and shaping its future" in the revitalization of the university's downtown precinct, the pedestrianization of Gould Street and the creation of multiple award-winning buildings contributing to the vibrancy of Toronto's downtown core.

**Varsity Athletics** – Ryerson is making its presence felt on the national intercollegiate scene:

- The Ryerson Rams Men's Soccer team made history this season, achieving a CIS ranking of #2 nationwide, finishing first in the OUA East with a 12-0-2 record, the only undefeated team in the country at the end of league play; qualifying for the CIS championship for the first time in team history; and celebrating the first Ryerson student-athlete to win CIS MVP honours in any sport with Alex Braletic as the recipient of the Joe Johnson Memorial Trophy for CIS Soccer Player of the Year. The team was defeated in hard-fought OUA/CIS playoff games in a season where they took the field with outstanding blue-and-gold talent and pride.
- Ryerson has been selected to host the 2015 CIS Final Eight Men's Basketball championship at the MAC, the first national CIS championship hosted by the university.
- Men's Basketball and Men's Volleyball teams have made the national CIS Top Ten rankings

**President's Platinum Breakfast** – On September 25th at the Mattamy Athletic Centre I was proud to host 43 student-athletes for their achievement: 23 CIS Academic All-Canadians, up seven from 2011-12, and 20 OUA Academic Achievement award winners, up six from the year

before (both CIS and OCUA awards require an 80% average). Student-athletes overall had a 2.77 GPA, with more than 40 per cent having a GPA above 3.0 in 2012-13.

**Fall Convocation** – Ryerson awarded 846 bachelor degrees, 613 graduate degrees, and 366 continuing education certificates to 1,825 graduates crossing the stage, joining more than 155,000 Ryerson alumni worldwide. The involvement of the Board in Convocation, and the celebratory dinners for our honorary doctorates, is very meaningful and greatly appreciated.

**Social Justice Week** –The theme of the 3rd Annual Social Justice Week from October 7-11th was *Rebuilding the We: This is What Solidarity Looks Like*, featuring speakers, exhibits and performances advancing understanding and shared responsibility on key issues of importance to us all. Topics included Decent Work For All; Idle No More: Reframing the Nation to Nation Relationship; Stitch a Home: Canada's Social Safety Net and Homelessness; Race, Law, and Social Justice; ReVision Disabilities; and more. Special thanks to Winnie Ng, Gindin Chair in Social Justice and Democracy, for leading an important week in our annual calendar.

**Alumni Weekend** – Our annual 'welcome back' is getting bigger all the time, and offering an experience to our guests combining social activities with an update on Ryerson development. It is clear that, as the university's reputation grows, so does the strength of our alumni connection. We received so many positive comments, and it is great to report that we are going to need a much bigger venue for the Ryerson Dinner. Congratulations and thanks to Adam Kahan, Vice President University Advancement, Tyler Forkes, Executive Director, Alumni Relations, and the Alumni Weekend team for engaging the blue-and-gold spirit of this vital Ryerson community.

Ontario Universities Fair – At the annual event for prospective students and their families, Ryerson continues to stand out for offering first-hand academic contact, and the chance to talk to more than 600 Ryerson faculty, staff and student volunteers. More than 121,000 visitors overall attended the Fair; Ryerson liaison officers gave presentations every hour, and 35,000 handbooks and 15,000 lanyards were distributed to those dropping by the Ryerson booth. As always, there were many great tweets from students attending the Fair, for example:

Loved the Ryerson presentation at OUF 2013! Ryerson is seriously the perfect school for me, I have so much motivation to study hard! Today I found out I'm destined to go to Ryerson U!

**United Way** – The goal of the 2013 campaign is \$210,000 building on the generosity that earned Ryerson a United Way Toronto Exemplary Award in 2012. The United Way message "build up a person, build up a community" resonates with Ryerson as a city-builder, and the values and goals we share in helping those who need us most. Special thanks to campaign co-chairs Tony Conte, Office of the Vice-Provost, Students; John Corallo, University Business Services; Janet Hercz, Capital Projects and Real Estate; John Isbister, Office of the Provost and Vice-President, Academic; Jennifer Mactavish, Yeates School of Graduate Studies; and Terry Marks, Office of the Vice-President, University Advancement, for their leadership of the Ryerson campaign.

- @ **Ryerson** The university has been the venue for significant public announcements in recent weeks, including the following programs and initiatives:
- September 23, 2013 The Hon. Jim Flaherty, federal Minister of Finance, was on campus to announce a Request for Proposals on the government Venture Capital Action Plan, a 5-year \$60 million funding program for entrepreneurs and start-ups. Asked why he chose the DMZ

- for the announcement, the Minister called it "a global leader in creativity and innovation" and said "there is no better place than here" for developing ingenious applied technology.
- October 1, 2013 Ryerson students joined the Hon. Dr. Kellie Leitch, Minister of Labour and Minister of Status of Women, to launch Women's History Month 2013: Canadian Women Pioneers: Inspiring Change Through Ongoing Leadership. Also involved in the launch were Dr. Roberta Bondar, Canada's first female astronaut and the first neurologist in space and Julia Hanigsberg, Vice President, Administration and Finance.
- October 1, 2013 The Hon. Bob Chiarelli, Minister of Energy, was on campus to announce *The Energy Apps for Ontario Challenge*, offering \$50,000 to create new apps that will help consumers monitor electricity use, conserve energy and save money.
- October 4, 2013 The Hon. Brad Duguid, Minister of Training, Colleges and Universities, announced \$3.7 million over two years as part of government's \$257 million Mental Health and Addictions Strategy: including the Good2Talk helpline, and ten projects including two led by Ryerson: \$440,000 for University Virtual Ward (with the University of Toronto, York University, Women's College Hospital) to help hospitalized students transition back to school; and \$281,250 for Speaking your Language (with the University of Toronto, OCAD University) to develop mental health support for international students and new Canadians.
- October 7, 2013 At the DMZ the Council of Ontario Universities (COU) launched Entrepreneurship at Ontario Universities: Fuelling Success, a report that recognizes that entrepreneurship has moved from the margins to the mainstream of university education in Ontario, with almost half of Canada's students planning to start a business after graduation.
- October 21, 2013 Premier Kathleen Wynne announced Ontario's new Open Government initiative at the Digital Media Zone, focusing on open dialogue, new tools and technologies, and open data and spent some time engaging with DMZ teams.
- October 24, 2013 CRTC Chair Jean-Pierre Blais was on campus announcing the launch of "a conversation with Canadians" on the future of TV in an evolving digital world.
- October 24, 2010 The #BringItHome Sochi 2014 Olympic Winter Games campaign was launched at the MAC, designed to build the spirit of home field advantage and national pride.

The referendum question was approved and the new fee will be collected starting September 2014 and will be adjusted to provide for any increase in the Toronto Consumer Price Index.

On September 30, 2013 the Board of Governors of Ryerson University approved the holding of a referendum for the Ryerson Engineering Student Society to ask for support from amongst their membership to increase the fee currently charged to students to fund RESS activities.

#### **BACKGROUND**

The Ryerson Engineering Student Society was formed in 1988 and uses the funds that it collects to support engineering student groups, provide academic and career events, publications, leadership training, social events and community service activities. RESS is holding a referendum for a fee increase that will provide additional funds for student engagement activities. The levy was originally \$20 when created in 1988 with no inflationary adjustment and remained unchanged for 18 years. In 2006 RESS held a referendum to increase the fee which now sits at \$33.70 per year for students enrolled in a full-time undergraduate engineering program.

#### **PROPOSAL**

THAT the Ryerson Election Procedures Committee will hold a student referendum, amongst all full-time undergraduate engineering program students to seek approval for an one-time increase of \$15.65 per Fall and Winter semester (for a total fee of \$65 per year), starting in September 2014, to be paid by all students enrolled in a full-time undergraduate engineering program, to fund the activities of the Ryerson Engineering Student Society. The increased compulsory fee be adjusted to provide for any increase according to the Toronto Consumer Price Index (CPI).

#### **QUESTION**

Do you agree to an annual levy of \$65 (which represents an increase of \$15.65 per semester) to be paid by all students enrolled in a full-time undergraduate engineering program, starting September 2014 and increased for inflation annually by the CPI of Toronto, to fund the activities of the Ryerson Engineering Student Society?

On September 30, 2013 the Board of Governors of Ryerson University approved the holding of a referendum for The Ryerson Communication and Design Society to ask for support from Faculty of Communication and Design students to create a levy to fund a new student society and its activities.

#### **BACKGROUND**

The Ryerson Communication and Design Steering Committee has been working for the past year developing the vision, organizational structure, constitution, by-laws and financial plans for a new student society linking students in programs within the Faculty of Communication and Design. This will be a student led faculty wide organization similar in structure and purpose to the Ryerson Engineering Student Society and the Ryerson Commerce Society. With the Board's approval they plan to hold a referendum to create a levy that will provide sustainable funding for the new society.

#### **PROPOSAL**

The Ryerson Election Procedures Committee will hold a student referendum amongst Faculty of Communication and Design students enrolled in full-time programs, to seek approval for the creation of a fee of \$60.00 per year, starting in September 2014, to be paid by all students enrolled in a full-time FCAD program, to fund the creation and operation of the Ryerson Communication and Design Society. The compulsory fee will be adjusted to provide for any increase according to the Toronto Consumer Price Index (CPI).

#### QUESTION

Do you agree to the creation of a fee of \$60.00 per year to be paid by all students enrolled in a full-time FCAD program, starting in September 2014 and increased for inflation annually by the CPI of Toronto, to fund the creation and operation of the Ryerson Communication and Design Society?

Wagner maintained a GPA of 4.07 while dedicating herself to community outreach. She has worked under the supervision of Professor Trevor Hart in the HIV Prevention Lab and is now a postdoctoral fellow working alongside Professor Candice Monson in the IMPACT Lab researching the development, prevention and treatment of post-traumatic stress disorder.

### Ryerson University Board of Governors Provost and Vice President Academic Report for meeting of November 25, 2013



#### WELCOME

Cathy Crow, Distinguished Visiting Practitioner, Faculty of Arts – announced at the second annual Jack Layton Lecture, the appointment will include collaboration with Myer Siemiatycki, Jack Layton Chair, on launching the Jack Layton Summer School for Youth Activism. Cathy Crow is the award-winning co-founder of the Toronto Disaster Relief Committee that declared homelessness a national disaster; subject of the documentary Street Nurse; author of Dying for a Home: Homeless Activists Speak Out, and executive producer of Home Safe Toronto, Home Safe Calgary, and Home Safe Hamilton, national documentary film and community development projects on homeless families and children.

John Ralston Saul, Distinguished Visiting Professor, Faculty of Arts – renowned Canadian essayist and novelist, champion of freedom of expression, accomplished public speaker and thought leader on the complexities of modern society, whose works have been translated into 22 languages in 30 countries. The appointment will include an annual John Ralston Saul Big Idea public discussion series, engaging with undergraduate and graduate students, advising on partnerships and independent research.

**Adel Sedra**, Distinguished Ryerson Fellow – one of Canada's leading academics and university administrators, appointed as a special advisor to the provost on academic leadership, and will provide strategic advice to Ryerson's senior academic administrators. An electrical engineering professor, renowned researcher and former provost at the University of Toronto, and former dean of engineering at the University of Waterloo, Dr. Sedra has served as a consultant to industry, governments and academic institutions in Canada and the US.

**John Lorinc**, award-winning freelancer reporter and author, and **Elizabeth Renzetti**, veteran Globe and Mail columnist and editor, have been appointed as Rogers Distinguished Visiting Professors with the School of Journalism, and will each teach an upper-year journalism course and advise on curriculum in the context of the evolving media landscape.

#### **ACADEMIC DEVELOPMENT**

- At its meeting of November 5th, the University Senate approved:
  - three new minors offered by the Department of Geography Minor in Geography, Minor in Geographic Analysis, and Minor in Environment and Urban Sustainability, to provide options for interdisciplinary study and professional careers, e.g. responding to students pursuing an education degree with geography as a second "teachable" subject, and providing students in other programs with the scientific, technological, and socio-cultural scope of contemporary environmental challenges in today's world;

- an optional specialization in engineering innovation and entrepreneurship, expected to launch in May 2014, linking our accredited engineering curricula to increasing demand from students considering entrepreneurship as a career option; the designation "Optional Specialization in Engineering Innovation and Entrepreneurship" will appear on the student's academic transcript upon successful completion;
- a name change from Department of Criminal Justice to the Department of Criminology, and a corresponding name change in the degree program from the bachelor of arts (Criminal Justice) to the bachelor of arts (Criminology), reflecting interdisciplinary breadth in teaching and research, and aligning the name with programs at other universities.
- Architecture co-op program The Department of Architectural Science has launched the
  new Architectural Science Co-operative Education Internship (ASCEI) that will enable 15-20
  top third-year students to undertake a 16-month paid work placement or internship at an
  architecture or construction firm. ASCEI will provide students with a unique experiential
  learning opportunity to apply their skills in a professional environment in the Architecture,
  Engineering and Construction (AEC) industry. The first cohort of students will begin their work
  terms in May 2014.
- Paul H. Cocker Gallery The Department of Architectural Science opened the Paul H. Cocker Gallery on October 22nd in the Architecture Building, with an exhibition of architectural photography from the Canadian Architect Magazine Image Collection donated to Ryerson in 2009. Cover and Spread: Selections from the Canadian Architect Image Collection, developed and produced by architectural science students, faculty and staff, investigates the role and meaning of modernity in post-war Canada, and is supported by the Canada Council for the Arts, Canadian Architect and Ryerson University. The gallery, which will provide opportunities for exhibiting student and faculty work, is named for alumnus and lead donor Paul H. Cocker (Civil Engineering '70), a respected member of the design and construction community and a great ally to the Department of Architectural Science.

#### **FACULTY DISTINCTION**

- Dr. Kamal Al-Solaylee, Journalism, is the winner of the 2013 Toronto Book Awards for his acclaimed work *Intolerable: A Memoir of Extremes*. The announcement, made on October 9th, celebrated the book for "exploring the importance of family, the search for identity, how culture shapes us and stays with us throughout our lives, and the importance of freedom and opportunity in realizing your life." In his acceptance speech, Dr. Al-Solaylee dedicated his book to the city of Toronto.
- Dr. Gene Allen, Journalism, launched Making National News: A History of Canadian Press on October 22nd. An outstanding work of meticulous research and great stories about the first fifty years of the news agency that spanned the nation in the face of formidable geographic and competitive odds, the book is praised as "among the very best works of any that have been written about news agencies" and "an important contribution to a lively and ongoing theoretical debate of great significance the relationship between news media and the processes of national formation and globalization."

- Prof. Robert Burley, Image Arts, is featured at the National Gallery of Canada in Ottawa until January 5, 2014 in an exhibition produced by the Ryerson Image Centre. Robert Burley: The Disappearance of Darkness, captures the transition from the old photographic industry to the digital era, in photographs that document the decline of the industry's infrastructure.
- Dr. Alex Ferworn, Department of Computer Science, won 2nd Place in the Science Slam North
  America competition in Washington, D.C. on September 24th as part of an event run by the
  European Commission promoting interaction among global researchers and bringing science
  to non-experts in an original way. Finalists gave a 10-minute presentation to a live audience –
  a member of Ferworn's research team was hidden as a 'disaster victim' and uncovered by a
  rescue dog named Cazo whose bark released a robot from its harness. Other finalists were
  from Georgetown University, the Harvard-Smithsonian Center for Astrophysics, Montana
  State University and the University of Illinois. Regions around the world are hosting
  competitions with the winners competing in Brussels.
- Dr. Rheta Rosen, long-time director and pioneer of the Ryerson Interpersonal Skills Teaching Centre (ISTC) Simulated Client Program, was recognized on the occasion of the ISTC 20th Anniversary with the naming of the Rheta Rosen Room in her honour; last year more than 16,000 on-campus and external clients were assisted by the experiential learning tool that helps develop communication, leadership and team-building skills.
- Dr. Reena Tandon, Community Engaged Learning and Teaching (CELT) co-ordinator for the Faculty of Arts, was among 27 rising leaders from public, private and non-profit organizations across the GTA to receive a 2013 DiverseCity Fellowship supported by CivicAction.
- Dr. Kathryn Woodcock, Occupational and Public Health, received the I. King Jordan Award from the Association of Late-Deafened Adults (ALDA) for her distinguished career, contributions to her community and serving as a role model for late-deafened adults. The award is the highest honour presented by the ALDA board of directors.

#### STUDENT AND ALUMNI ACHIEVEMENT

- Engineering and science students Mahmoud Al-Fayez, Mo'tasem Aljawhary, Yousuf Faroqi,
  Osama Al-Mohammedi, and Shahid Quraishi won First Place in the 2013 American Concrete
  Institute (ACI) pervious concrete competition in Phoenix, achieving a mixture with optimized
  permeability and split tensile strength.
- Karen Quinto, 4th-year Environmental Science, and Josh Tzventarny (Urban and Regional Planning '07) won awards at the national 2013 Water Innovation Lab in September; Quinto won Most Innovative Pitch for microbial fuel cells harnessing electricity from soil bacteria, and Tzventarny won Best Overall Pitch for a Nunavut local beverage enterprise.
- Ivonne Serna (Master's Fashion) received a 2013 City of Toronto International Students
  Recognition Award in the Entrepreneurship category for her business, Tycra Wear, advancing
  a School of Fashion focus on inclusion with fashionable footwear for diverse body shapes.
- Graeme Smith (Journalism '01) won the 2013 non-fiction Hilary Weston Writers' Trust Prize for The Dogs Are Eating Them Now, a memoir chronicling six years of reporting in southern Afghanistan for the Globe and Mail.

 Emily Wong, Tabea Lemcke, Christopher Ambedkar and Jessica Klein, School of Graphic Communications Management, were among 48 recipients of Electronic Document Scholarship Foundation (EDSF) scholarships awarded at a gala industry event held in Chicago in September; Ryerson offers the only degree-granting program in Canada for managers in the printing industries.

#### **PARTNERSHIP**

- CUE Anna University CUE-Anna University Partnership On October 15th we welcomed
  a delegation from Anna University to Ryerson, including Professor Dr. M. Rajaram, Vice
  Chancellor; Dr. A. Azad, Director, Centre for International Affairs, and Dr. S. Chandramohan,
  Director, AU-Ryerson Urban Energy Centre. In September twenty graduate students in
  Chennai, India began a two-year Master's program in Power Engineering and Management,
  launched by the Anna-Ryerson Urban Energy Centre, created as part of the agreement
  signed in 2011. Based in the Faculty of Electrical Engineering at Anna University, the program
  includes courses advancing knowledge and management of climate change, renewable
  energy, smart grids and related issues.
- Aerospace research and training The Ontario government has announced an investment of
  up to \$26 million to relocate Centennial College aviation programs to the former de Havilland
  aircraft manufacturing centre at Downsview Park. The centre, expected to be ready in 2015,
  will provide new classrooms, workshops and hangar space, and house an innovation and
  research working group of industry leaders and academic partners, including Ryerson
  University, the University of Toronto and York University.

#### 3. INTRODUCTION

#### Chair's Remarks

The Chair welcomed new Board members Khatera Noor, Darren Shivraj, Michelle Dionne, Kim Varma and Darius Sookram. Curtis Yim was unable to attend the Board meeting because he was participating at the Enactus World Cup in Cancun. Branka Halilovic was re-elected to the Board for a second term.

The Chair reported that the President had been selected as one of the 50 most powerful people in Canadian Business Today magazine. She congratulated Erin McGinn and her team for the coverage.

Vice Chair, Janice Fukakusa was recently named one of the 25 most powerful women in banking by American Banker Magazine.

The Chair thanked Adam Kahan for hosting the film and the reception of the Jennifer Baichwal and Edward Burtynsky's film "Watermark".

The Chair remarked on presentations made to each Board member namely, sample baskets supplied by Zacherie Weingarten of Foodstory, Marlissa Flint's Mai Lin bracelet given by Wendy Cukier and FCAD Image Arts Student book given by Mohamed Lachemi.

The Chair advised Board members on their governance role, encouraged their participation at the upcoming convocations; senate meetings and financial literacy sessions and advised them on a number of housekeeping matters.

#### 4. REPORT FROM THE VICE PRESIDENT RESEARCH AND INNOVATION

Advancing Scholarly Research and Creative (SRC) Activity, Innovation & Internationalization at Ryerson

Wendy Cukier presented an overview of SRC and innovation at Ryerson University. The presentation focused on the types of research the University is doing, its impact on the community, business and students, industry partnerships and building a culture of innovation. Dr. Cukier reported that the total research funding at Ryerson has tripled in the last decade with significant increases in our market share. For 2012-13 it has reached an all-time high of \$32.3 million.

At this point Phyllis Yaffe left the meeting and Janice Fukakusa chaired the meeting.

#### 5. REPORT FROM THE PRESIDENT

The President welcomed new Board members and also mentioned the appointment of John Turtle as Secretary of Senate.

Julia Hanigsberg introduced two new administrators Christine Sass-Kortsak, Assistant Vice President and Joshna Maharaj, Assistant Director, Food Services and Executive Chef. Ms. Hanigsberg spoke of the new sustainable and healing approach to food services at Ryerson.

The President reported that Stephen Murphy, Dean of Ted Rogers School of Management was currently in Cancun participating in the Enactus competitions.

The President congratulated Michèle Maheux for her stewardship of the Toronto International Film Festival and noted that at least ten of the TIFF films were made by Ryerson alumni and students.

The President also mentioned the importance of the connections established at the Canadian University Fair, which had just concluded.

The President updated Board meetings of the Ministry of Training, Colleges and Universities Roundtable meetings and Differentiation Framework.

Julia Shin Doi reported on the upcoming Council of Chairs of Ontario Universities Conference on November 8 and 9<sup>th</sup> of November. Sheldon Levy will be speaking at the conference on November 9.

#### 7. REPORT FROM THE PROVOST AND VICE PRESIDENT ACADEMIC

The Provost reported on the appointment of Randy Boyagoda as the Director, Zone Learning and Nancy Walton, appointed Director, E-Learning.

The Provost updated Board members on two ongoing searches for the Deans of Ryerson Engineering and Architectural Science Faculty and the Chang School of Continuing education.

Sixty eight new faculty have joined Ryerson from across Canada, the States and Australia.

The Provost noted that demand continues to be strong in undergraduate and graduate applications and there continues to be a rise in the quality of secondary school applicants.

The Provost spoke of student participation in orientation which is a reflection of the strength of student life at Ryerson.

The Provost also spoke several new pilot project in zone education; new initiatives to strengthen

student engagement and the launch of several new academic programs.

Janice Fukakusa thanked the Provost for the gift of the IFCAD Image Arts book.

#### 8. DISCUSSION ITEMS

#### 8.1 Report From The Chair Of The Executive Committee

The President reported that Executive Committee met on Wednesday, September 18, 2013 and, acting on behalf of the Board approved the filing of the January 1, 2013 Valuation Report for the Ryerson Retirement Pension Plan with the Canada Revenue Agency (CRA) and the Financial Services Commission of Ontario (FSCO). The final valuation results were unchanged from the June 19, 2013 presentation to the Employee Relations and Pension Committee. The surplus on a going concern basis stands at \$17 million.

The Executive Committee also approved a recommendation to re-appoint Mohammad Al Zaibak as a Lieutenant-Governor-in-Council appointee to the Board for a second term, beginning on November 29, 2013. This recommendation has been sent to the Minister of Training, Colleges and Universities and to the Public Appointments Secretariat. The appointment is then approved by Cabinet and signed by the Lieutenant Governor.

At this same meeting, the Executive Committee, acting on behalf of the Board, approved the appointment of Mohammad Al Zaibak to the Audit Committee.

As a final piece of business the Executive Committee members were advised that alumni Board member Atifa Rasoul has accepted employment with the university. Accordingly, Atifa will be stepping down from her Board position as she is no longer eligible to serve pursuant to the by-laws.

#### 8.2 Report From The Chair Of The Employee Relations And Pension Committee

The President reported The ERPC Committee met on Wednesday, September 18, 2013 and recommended filing the January 1, 2013 Ryerson Retirement Pension Plan valuation with the CRA and FSCO, which was approved by the Executive Committee as previously mentioned. The ERPC Committee also recommended that Towers Watson be approved for retention as Ryerson's Actuaries for 2014.

Appointment of the Actuary for the Ryerson Retirement Pension Plan

#### **Ryerson Communication and Design Society**

Heather Lane Vetere introduced student presenters Karina Cole and Cormac McGee from the Ryerson Communication and Design Society ("RCDS") Steering Committee who are seeking approval from the Board to hold a referendum asking for support from Faculty of Communication and Design students to create a levy to fund a new student society and its activities. The students made a brief presentation to the Board about the functioning of RCDS and its academic, professional and collaborative role in the life of Communication and Design students.

It was moved, seconded and carried:

BE IT AND IT IS HEREBY RESOLVED:

THAT the Ryerson Election Procedures Committee be authorized to hold a student referendum, at a time to be determined, amongst Faculty of Communication and Design students enrolled in full time programs, to seek approval for the creation of a fee of \$60.00 per year, starting in September

2014, to be paid by all students enrolled in a full-time FCAD program, to fund the creation and operation of the Ryerson Communication and Design Society.

THAT the compulsory fee be adjusted to provide for any increase according to the Toronto Consumer Price Index (CPI); and

THAT the specific wording of the referendum question be subject to approval by the Provost and Vice President Academic.

#### (b) Ryerson Engineering Students Society

Heather Lane Vetere introduced student presenters Rose Ghamari and Dante Zegarac from the Ryerson Engineering Student Society (RESS) who are seeking permission from the Board to hold a referendum asking its members for an increase to the RESS levy. The Ryerson Engineering Student Society was formed in 1988 and uses funds it collects to support engineering student groups, provide academic and career events, publications, leadership training, social events and community service activities. The levy was increased once since 1988 with a successful referendum in 2006 and RESS is looking for students to support an increase to the levy again for 2014. The presenters reported that increased demand for funding requests amongst RESS students is the main rationale for the fee increase.

THAT the Ryerson Election Procedures Committee be authorized to hold a student referendum, at a time to be determined, amongst all full-time undergraduate engineering program students to seek approval for an one-time increase of \$15.65 per Fall and Winter semester (for a total fee of \$65 per year), starting in September 2014, to be paid by all students enrolled in a full-time undergraduate engineering program, to fund the activities of the Ryerson Engineering Student Society.

THAT the increased compulsory fee be adjusted to provide for any increase according to the Toronto Consumer Price Index (CPI); and

THAT the specific wording of the referendum question be subject to approval by the Provost and Vice President Academic.

# I. Purpose

The purpose of this policy is to specify the signing authorities required for Contracts entered into on behalf of the University

# II. Objective

The objective of this policy is to ensure that only those individuals with appropriate approval and accountability sign contracts on behalf of Ryerson University.

# III. Scope or Application and Scope

This policy applies to all Contracts to which the University is a party or that create an obligation on the University. It applies to all faculty and staff. Contracts must be entered into only by employees of the University.

# IV. Definitions

"Contract" means any written agreement, contract (including any renewal, extension or amendment of an existing contract), subcontract, letter of intent, memorandum of understanding, memorandum of agreement, legal actions, memorandum of settlement, minutes of settlement, academic agreement, employment contract, gift agreement, lease, license, purchase requisition/order, deed, transfer, instrument, assignment, obligation, certificate or other document, the provisions of which may be binding upon the University.

"Research Contract" means a Contract for services or products to be provided by Ryerson faculty, staff or students in regard to research contracted or sponsored through external funding sources.

"Student Placement Agreement" means a Contract with an organization outside the University to provide students with discipline-related work experience as a partial component of an academic program.

### V. Policy

- You may only sign a Contract on behalf of Ryerson University if you have explicit authority to do so in this policy, or if that authority has been properly delegated to you by the appropriate member of the Executive Group.
- 2. Authority to sign a Contract is dependent on its total value. See Schedule A for signing officers by value and type of Contract.

- 3. Prior to presenting a Contract for signature by the appropriate signing officer(s), the following requirements must be met:
  - a. The Financial Services Department must review the insurance terms of the Contract.
  - b. An assessment of the risks to which the University may be exposed to by entering into the Contract must be prepared.
  - c. The business terms of the Contract must be reviewed and approved in advance by the appropriate member of the Executive Group.
  - d. The Contract must be reviewed by the Office of the General Counsel and Board Secretariat
- 4. The term of the Contract, including renewals and extensions, should be less than five (5) years in total, unless discussed with the Office of the General Counsel and Board Secretariat.
- 5. Signature stamps or pre-signed blank forms are not accepted as original signatures on Contracts.

# VII. Jurisdiction

This policy is under the jurisdiction of the General Counsel and Board Secretariat. Interpretation and administration is the responsibility of the General Counsel.

# VIII. Next Review Date

This policy is subject to review every three (3) years.

# **Schedule A: Authority for Signing Contracts**

# I. For all Contracts other than Research Contracts and Student Placement Agreements,

1.	If the Contract has a value of less than \$100,000 in the aggregate then it must be signed by one of

2. If the Contract has a value of \$100,000 in the aggregate but less than \$1,000,000 in the aggregate then it must be signed by **one** of the following:

General Counsel and Secretary of the Board of Governors

Vice President University Advancement

Vice President Research and Innovation.

3. If the Contract has a value of \$1,000,000 in the aggregate but less than \$5,000,000 or it has a value of any amount but is deemed to be significant to the reputation of the University, then it must be signed by any **two** of the following:

President and Vice Chancellor

Provost and Vice President Academic

Vice President Administration and Finance

General Counsel and Secretary of the Board of Governors

Vice President University Advancement

Vice President Research and Innovation.

4. If the Contract is a collective agreement or has a value of \$5,000,000 or more in the aggregate, then it must be approved in advance by the Board of Governors **and** must be signed by any two of the following:

President and Vice Chancellor

Provost and Vice President Academic

Vice President, Administration and Finance

General Counsel and Secretary of the Board of Governors

Vice President University Advancement

Vice President Research and Innovation.

5. If the Contract relates to legal actions (for example: minutes of settlement or memorandum of settlement) then it must be signed by the General Counsel and Secretary of the Board of Governors in addition to the signing authorities set out above.

# **II.** For all Research Contracts

1. If the Research Contract has a value of less than \$1,000,000 in the aggregate then it must be signed by any **one** of the following:

President and Vice Chancellor

Provost and Vice President Academic

Vice President Research and Innovation

General Counsel and Secretary of the Board.

2. If the Research Contract has a value of \$1,000,000 or more in the aggregate then it must be signed by any **two** of the following:

President and Vice Chancellor

Provost and Vice President Academic

Vice President Research and Innovation

General Counsel and Secretary of the Board.

# **III. For all Student Placement Agreements:**

- Student Placement Agreements for placements in Canada must be signed by the Provost and Vice President Academic and General Counsel and Secretary of the Board of Governors.
- 2. Student Placement Agreements for placements outside of Canada must be signed by the Provost and Vice President Academic and Vice President Research and Innovation.

# I. Purpose

The purpose of this policy is to specify the signing authorities required for various types of purchases and expense reimbursements. This policy formally complies with the Broader Public Sector Procurement and Expense Directives (Bill 122) which require that the University establish an Approval Authority Schedule for procurement of goods and services, approved by the Board of Governors.

# II. Scope

An Approval Authority Schedule defines who within the organization has responsibility for the procurement of goods and services at different dollar thresholds.

This policy applies to the procurement for goods and services for business related for the University. It applies to all faculty and staff.

This policy addresses the Expense Reimbursement authority approvals required by law.

# III. Definitions

- "Approver" means an individual is authorized to approve a purchase/ expense reimbursement for the total spend amount (normally one level up unless otherwise delegated).
- "Delegate" means to give someone the power to act, make decisions, or allocate resources on your behalf.
- "Delegated Individual" means a University employee with delegated authority in accordance with this
  policy.
- "Expense" means a valid university related business expense supported by original receipts dated and detailing the item and the total amount.
- "Purchase" means the purchase of all goods and services for University related business and University Departments are to follow Ryerson's Purchasing Policy and Procedures.
- "University" means Ryerson University.
- "Up any number of levels" means a position to whom the delegator, or the delegator's manager, reports.

# IV. Policy

The Approval Authority Schedule establishes the authority that is required for each functional procurement role, to approve procurements of goods and services, both consulting and non-consulting, at different dollar thresholds. It also establishes the authority approval that is required for approving expense reimbursements (including Travel and Business Meals).

- 1. The purchase of goods and professional services must adhere to the Ryerson Purchasing Policy and Procedure. The Approval Authority Schedule for iProcurement purchases initiated by the Department requisitioner is a pre-established hierarchy of approvals in the University's financial system and is dependent on the total dollar spend unless otherwise delegated.
- 2. The purchasing policy language for procuring consulting service quotations must be closely observed as approval is required regardless of dollar spend.
- 3. Research Funding Agency (NSERC, SSHRC, etc.) purchase requisitions must be approved by the Vice President, Research and Innovation or Designated Individual. The Funding Agency policy takes precedence over this policy.

# VII. Jurisdiction

This policy falls under the jurisdiction of the Vice President, Administration and Finance. The interpretation and application of this policy is the responsibility of the Chief Financial Officer. The Budget Authority is as approved by the Board of Governors or granting agency and/or as delegated by the President.
