

INTERNATIONAL AND CANADIAN CHILD RIGHTS PARTNERSHIP (ICCRP)

ABOUT OUR RESEARCH

WE AIM TO ANSWER THE QUESTION OF HOW CHILDREN'S PARTICIPATION IN INTERNATIONAL AND CANADIAN CHILD PROTECTION PROGRAMS AND POLICIES CAN BE MONITORED. WE HAVE TEAM MEMBERS AND PARTNERSHIP COUNTRIES IN CANADA, SOUTH AFRICA, BRAZIL, THE UK AND CHINA. OUR RESEARCH TEAM IS NOT COMPLETE WITHOUT OUR YOUNG PEOPLE INVOLVED IN OUR CHILD AND YOUTH ADVISORY COMMITTEE!

OUR RESEARCH IS DIVIDED INTO THREE PHASES:

PHASE I - WE IDENTIFIED CURRENT ACADEMIC LITERATURE ON MONITORING CHILD PARTICIPATION IN INTERNATIONAL PROTECTION. WE ALSO CONDUCTED KEY INFORMANT INTERVIEWS (KII) WITH STAKEHOLDERS AROUND THE WORLD. WE ALSO ESTABLISHED THE CHILD AND YOUTH ADVISORY COMMITTEE

PHASE II - AFTER THE INTERNATIONAL WORK, WE DEEPENED OUR WORK INTO DIFFERENT REGIONS. WE COLLECTED DATA IN 4 COUNTRIES WITH 5 DIFFERENT PROJECTS. (CANADA - ONTARIO & NEW BRUNSWICK, BRAZIL, SOUTH AFRICA AND CHINA). SEE "JURISDICTION SUMMARY" FOR MORE DETAILS). GUIDED BY OUR CYAC, WE CREATED THE FOLLOWING METHODOLOGIES: LOCAL CYAC, FOCUS GROUPS, KII WITH ADULT STAKEHOLDERS AND PARTICIPATORY MEETINGS INVOLVING YOUNG PEOPLE & ADULTS.

DETAILS ABOUT THE PARTICIPATORY MEETING:

- WE HAD 2 PARTICIPATORY MEETINGS IN ALL JURISDICTIONS. THE FIRST PARTICIPATORY MEETING DISCUSSED RESULTS FROM PHASE I (LOOKING INTO WHAT RELEVANCE THE RESULTS HAD FOR THE JURISDICTION, IF ANY) AND THE SECOND PARTICIPATORY MEETING FOCUSED ON CO-CREATING NEW IDEAS AND RECOMMENDATIONS ON MONITORING CHILD PARTICIPATION IN THEIR PROTECTION IN THE JURISDICTION.

PHASE III - OUR RESEARCH IS CURRENTLY IN PHASE III. WE ARE ANALYZING THE CONNECTIONS BETWEEN CHILDREN'S PARTICIPATION AND CHILD PROTECTION WITHIN EACH JURISDICTION AND THE OUTCOMES IN ALL JURISDICTIONS.



CHILD AND YOUTH ADVISORY COMMITTEE (CYAC)

OUR CYAC MEMBERS PLAY AN IMPORTANT ROLE TO OUR RESEARCH PROCESS. THEY INFORM OUR RESEARCH DESIGN, SUPPORT DATA ANALYSIS/COLLECTION, PROVIDE CONTENT FOR CONFERENCES, PROVIDE FEEDBACK, FACILITATE MEETINGS, WORK ON PUBLICATION PAPERS AND MORE. OVERALL, THEY PROVIDE GUIDANCE FOR OUR RESEARCH. WE HAVE CYAC MEMBERS FROM BRAZIL, SOUTH AFRICA, CANADA AND CHINA!

OUR WONDERFUL CYAC MEMBERS HAVE BEEN WORKING IN COLLABORATION WITH US IN BOTH INTERNATIONAL AND NATIONAL LEVEL (A.K.A "LOCAL CYAC"). THIS YEAR'S HIGHLIGHTS ARE: PROVIDING GUIDANCE TO KII QUESTIONS, LITERATURE REVIEW, FACILITATING PARTICIPATORY MEETINGS, CONFERENCE SUPPORT (CATS, IPSCAN & DAY OF DISCUSSION OF THE UN COMMITTEE ON THE RIGHTS OF THE CHILD) AND THE CYAC PAPER. FOR NEXT YEAR, CYAC MEMBERS WILL BE INVOLVED IN MORE CONFERENCE SUPPORT, FINALIZING THE CYAC PAPER, DESIGNING THE ICCRP LOGO, AND MORE.

JURISDICTION SUMMARY

BRAZIL: FOCUSING ON YOUNG'S PEOPLE PARTICIPATION ON THE STATE COUNCIL ON THE RIGHTS OF CHILDREN AND ADOLESCENTS IN RIO DE JANEIRO (CEDCA-RIO).

CHINA: EXAMINING IN COLLABORATION WITH PROJECT PARTNER RIGHT TO PLAY CHINA ITS CHILD PROTECTION PROGRAM THAT AIM TO BUILD AND STRENGTHEN AN EFFECTIVE AND REPPLICABLE CHILD PROTECTION SYSTEM IN CHINA.

SOUTH AFRICA: WORKING WITH NATIONAL ASSOCIATION OF CHILD CARE WORKERS (NACCW), WE ARE FOCUSING ON THE ADOLESCENT AND YOUTH DEVELOPMENT PROGRAMME (AYDP) IN PARTNERSHIP WITH THE DEPARTMENT OF SOCIAL DEVELOPMENT WITH THE SUPPORT OF UNICEF.

ONTARIO, CANADA: ADDRESSING THE QUESTION OF HOW TO INVOLVE YOUNG PEOPLE IN THE DEVELOPMENT OF COLLEGE CURRICULA FOR CHILD AND YOUTH CARE (CYC) PRACTITIONERS.

NEW BRUNSWICK, CANADA: MONITORING THE ENGAGEMENT OF YOUNG PEOPLE IN THE YOUTH VOICE COMMITTEE CREATED TO SUPPORT THE NEW BRUNSWICK PROVINCIAL HARM REDUCTION STRATEGY CALLED "KEEPING CHILDREN AND YOUTH SAFE FROM HARM IN NEW BRUNSWICK" (2015).
