June-August - Drafted & edited recruitment & consent materials
September - Finalized & translated documents into local languages
Early October - Recruitment through informed consent processes & meeting planning
Late October - First IAC meeting

Then they will join regular intergenerational meetings with the adult advisors on the IAC. We are so excited to welcome the new children and young people to join the ICCRP!

September 30th is the National Day for Truth and Reconciliation, also known as Orange Shirt Day in Canada.

Orange Shirt Day is an opportunity for everyone to engage meaningfully in discussions about colonization, oppression, and the forced removal of Indigenous children and young people from their homes and families. This day highlights the importance of critical conversations and actions about all aspects of the treatment of Indigenous peoples both historically and currently in Canada and across the globe. It is a day centred on reconciliation and for survivors of residential schools to be reaffirmed, heard, and supported. It is also a day to remember Indigenous lives lost at residential schools. The ICCRP recognizes that this effort should not only be limited to September 30th but that reconciliation is part of our ongoing work. We are focused on **learning, reflecting, and decolonizing children's rights** locally, nationally, and globally every day.


