## Join Us for the IAC's Next Roundtable – May 30, 2025



## Great News! The ICCRP's Mid-Term Report Was Approved: Our Research Continues for 4.5 More Years

The International and Canadian Child Rights Partnership (ICCRP) is thrilled to announce that our **Mid-Term Report has been approved, securing our research for another 4.5 years!** Originally a seven-year SSHRC-funded project, the ICCRP received an automatic one-year extension until March 31, 2029.

Over the past four years, we've built a strong foundation, deepened partnerships, and made significant contributions to children's rights research.

We extend **our deepest gratitude to our research assistants, children and young people, partners, co-applicants, collaborators, and staff.** Your dedication makes this work possible! **Stay tuned for more updates as we continue our mission to advance children's rights worldwide!** Please see the below textboxes for some of our key achievements over the past four years:

### Year 1 (April 2021 – March 2022)

Throughout **Year 1 of the Partnership Grant (April 1, 2021-March 31, 2022)**, the ICCRP focused on building a strong foundation for the project. Key achievements included hiring new staff, such as the fantastic Child and Youth Participant Coordinator Sachi Shukul, and fostering collaboration across teams through newsletters, virtual meetings, and community events. The project continued to influence international children's rights efforts, with organizations seeking the partnership's advice on child and youth participation. The team also prepared for major initiatives like case studies, ethics protocols, and working groups, while enhancing communication through website updates, newsletters, and a new LinkedIn page. The successful Launch Meeting in January 2022 and ongoing engagement from partners worldwide, highlighted the project's momentum, with strong interest in knowledge sharing, leadership opportunities for young people, and future ICCRP working group involvement.



### Year 2 (April 2022 – March 2023)

### Year 2 (April 2022 – March 2023)

During **Year 2 of the Partnership Grant (April 1, 2022 – March 31, 2023)**, the project advanced in several key areas. Monthly Steering Committee meetings support decision-making and efforts, and recruitment for the Intergenerational Advisory Committee (IAC) expanded to include new organizations and locations. A major grant application was submitted to the Ontario Research Fund (ORF-RE) to leverage the project. New staff, including a postdoctoral fellow and a graphic designer, enhanced research coordination, ethics protocol development, and project branding. Key meetings, such as the first joint gathering of case study, working group, and steering committee members, aligned timelines and research frameworks. Ethics approvals progressed, including clearance for our largest Case Study 2b: Child and Youth Activism Project (CYAP) case study in Canada, Brazil, Scotland, and South Africa. The IAC became operational with active child and youth recruitment supported by valued partner organizations. Partnerships were strengthened and travel planning began for two valued Canadian research assistants to travel to the Children's Institute, Univ. of Cape Town. Progress in outcome mapping with Matter of Focus also enhanced impact tracking. The fiscal year concluded with preparations for the ICCRP's first in-person conference and recognition of the valuable contributions from young participants and staff.

### Year 3 (April 2023 – March 2024)

In **Year 3 of the Partnership Grant (April 1, 2023-March 31, 2024)**, the ICCRP formed a Travel Planning Working Group to support logistics for 12 IAC youth and their chaperones attending the postponed in-person conference, now set for Year 4. Key partnerships were deepened through successful decolonial-themed webinars held in May 2023. The ICCRP also expanded its outreach through the launch of a new Twitter account. New research assistants (RAs) were hired, and Brazilian student Laís Ramos joined the team through CBIE's Emerging Leaders in the Americas Program (ELAP). The ORF-RE project was launched with provincial funding, and RAs Sheldon and Sachi gained valuable experience in Cape Town. Despite ongoing ethics and administrative challenges, the project secured additional partner contributions and welcomed two new partner organizations. A successful virtual intergenerational keynote was delivered in October for the Ontario Association of Child and Youth Care. The project advanced the CYAP curriculum map and held inaugural meetings of both the Steering Committee and IAC youth group. A virtual roundtable on adult-youth engagement also received positive feedback. Coordination continued on international logistics, including visas and funding transfers, while ethics work progressed across several case studies.

### Year 4 (April 2024 – March 2025)

Throughout **Year 4 of the Partnership Grant (April 1, 2024-October 31, 2024)**, the ICCRP has made significant progress while overcoming several challenges. Key successes include securing visas for international researchers and young participants. In July 2024, the partnership hosted its first in-person Partnership & Engagement Event at the Elephant Thoughts Eco Resort, welcoming 52 members, including research assistants, partners, and youth participants. This event marked a pivotal transition from virtual collaboration to in-person interaction, fostering stronger connections and dynamic knowledge exchange. Despite logistical challenges, such as travel complications, poor weather affecting the rustic accommodations, the event was a resounding success, featuring activities like the "Gallery Poster Walk" and a "Decolonization Circle" that deepened engagement and highlighted the value of face-to-face collaboration. The ICCRP enhanced its operations by introducing a new email address, protocols for data security, creating standing banners with social media links for greater visibility, and refining project management processes, including RA task delegation and budget alignment between the PG and Ontario Research Fund grant. While challenges such as GDPR compliance, ethics approval delays, and travel logistics remained, the partnership continues to make meaningful strides in promoting children's rights globally.



## Youth Participation in Brazil: New Poster Highlights Key Findings



Our valued colleagues at Centro Internacional de Estudos e Pesquisas sobre a Infância (CIESPI), have **released a new poster** summarizing the findings and outcomes of their ongoing [ICCRP case study on "Youth Participation and Protagonism in Brazil"](#). From 2022 to 2024, the Brazil case study team conducted numerous intergenerational activities, including interviews, seminars, and participatory workshops, involving over 1,400 children and youth. These initiatives led to increased visibility of youth demands, tangible improvements in school infrastructure, and enhanced dialogue between youth and municipal councils. Key challenges, such as the lack of institutional support and continuity, were also identified. The poster showcases the collaborative efforts to strengthen youth voice in public policy and highlights recent publications that promote youth rights and civic engagement. 
## ICCRP Research Facilitator Receives Graduate Scholarship to Honour Nelson Mandela




### Decolonizing Children's Rights is an academic poster developed
