## EQUITY, DIVERSITY AND INCLUSION

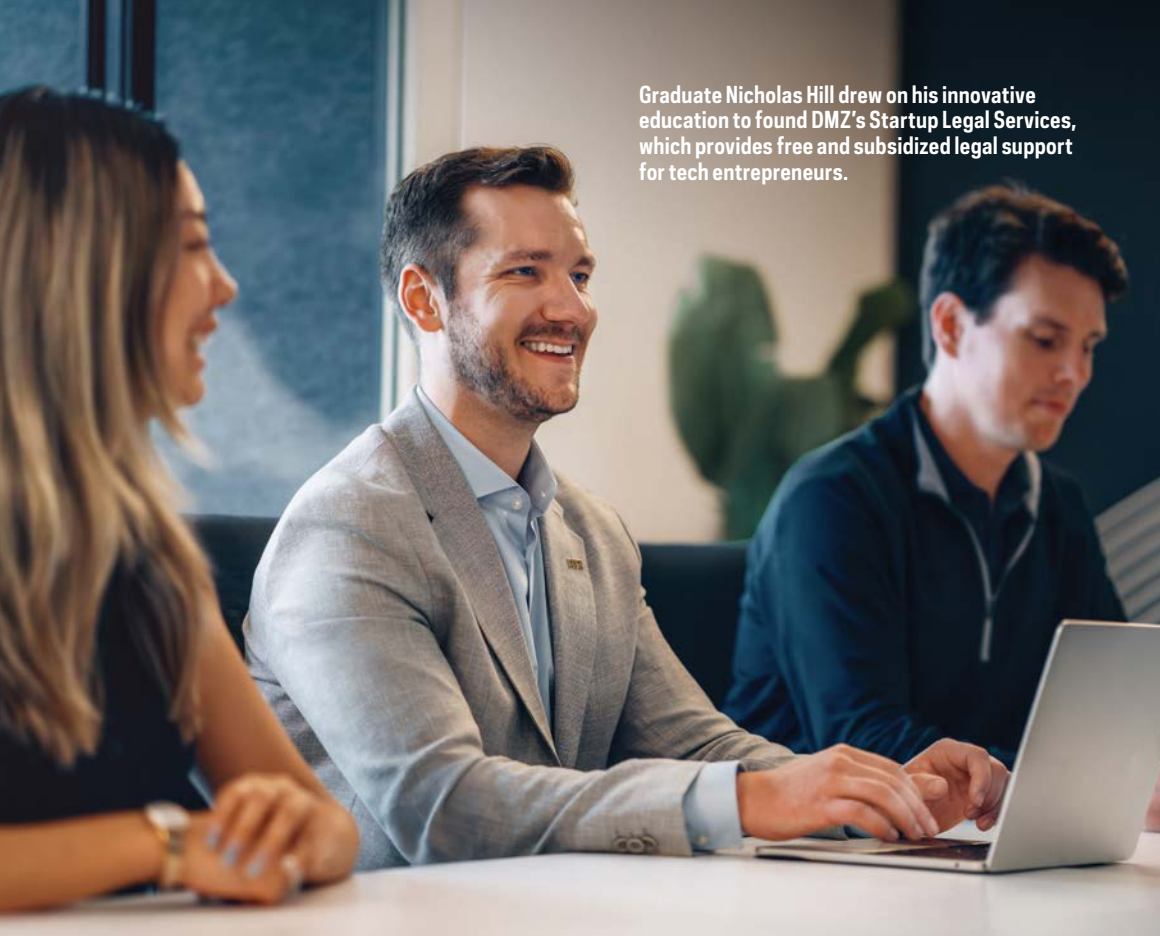

The Lincoln Alexander School of Law is home to Toronto's only Juris Doctor program accredited by the Law Society of Ontario as an Integrated Practice Curriculum (IPC), a unique learning model that blends academic excellence with real-world legal training. The IPC equips you with the experience, skills and professional judgment to enter practice with confidence in today's evolving legal landscape.

Through our distinctive program, you have the option of becoming a licensed lawyer without completing the traditional articling requirement. The choice is yours, and we'll support you regardless of the path you take.

## HOW IT WORKS

From day one, our IPC blends academic learning with practical training. In your first year, you'll experience our distinctive co-teaching model, wherein accomplished law professors and practicing lawyers work side by side in the classroom to bring you a comprehensive legal education that melds rigorous legal theory with industry insights.

Throughout your education, you'll complete intensive courses, which are week-long, full-time classes designed to get you practice-ready through applied learning and assessments. You'll participate in experiential learning opportunities that reflect the realities of today's legal professionals, and benefit from regular personalized mentorship and close interaction with your peers, staff, faculty and members of the profession.

In your final year, you'll complete a 15-week professional placement, guided by faculty and under the tutelage of a professional lawyer, where you'll apply your learning in a real-world legal setting.

Upon graduation, you'll be eligible to fulfill your licensing requirements without traditional articling, giving you a more direct path to becoming a practicing lawyer. Whether you choose to work in private practice, business, government or the non-profit sector, the IPC ensures you graduate ready to lead with confidence, flexibility and purpose.



# Your Juris Doctor program

At the Lincoln Alexander School of Law, you'll prepare to thrive in today's dynamic legal landscape with a curriculum focused on experiential learning, innovation and mentorship. In addition to building a strong foundation in legal theory, you'll develop the practical lawyering skills, interdisciplinary insight and entrepreneurial mindset you need to serve a wide range of clients within a wide range of careers.

## YEAR 1

Build practice-ready skills in the classroom through our unique co-teaching model, wherein faculty and practicing lawyers work together to bridge legal theory and doctrinal analysis with real-world experience.

# Admissions

We believe that excellence and reflexivity in the legal profession are essential to public trust and institutional legitimacy. That's why we seek students who bring a wide range of academic, professional and lived experiences: because law is best taught, practiced and advanced by those who can understand it from multiple vantage points and apply it with insight and integrity.

We assess each application holistically, and take into account the following when evaluating an applicant's potential:

- Official transcripts  
(of all post-secondary studies)
- Official LSAT score (best result)
- Personal statement
- Letters of reference
- Résumé and autobiographical sketch
- Online interview
- English proficiency

---

## APPLICATION CATEGORIES

### General

This is the standard route for most applicants who have completed or are completing an undergraduate university degree.

### Indigenous

If you identify as First Nations, Métis or Inuit, Lincoln Alexander Law offers a dedicated Indigenous application category designed to support and honour your lived experiences. Your application is reviewed by a member of our Indigenous community, ensuring that it is considered with context, care and understanding.

### Access

The Access application category provides applicants with an opportunity to identify and discuss any personal, academic or systemic barriers they may have experienced or overcome. This category includes, but is not limited to, Black individuals, people of colour, people with disabilities, 2SLGBTQ+ individuals, mature applicants, and those who have faced financial or systemic hardship.



Not sure which application category to choose? Start with the one that feels the truest to your journey. And if you need guidance, our Recruitment and Admissions team hosts application workshops throughout the year. We're here to help you throughout the process.

## FINANCIAL AID AND SCHOLARSHIPS

We're dedicated to supporting students through scholarships, bursaries and financial aid. We have entrance scholarships and substantial awards for students with financial need from historically underrepresented groups, and for students who demonstrate academic excellence, including an aptitude for business and entrepreneurship. Domestic students may qualify for Ontario Student Assistance Program (OSAP) grants and loans, which are applied to tuition fees. Professional student lines of credit are also available through banks, with preferred loan options for Canadians and permanent residents. We encourage you to explore all financial options to find the best fit for your needs.
