**Context** - A brief literature review to situate the project, its relevance and its potential contributions.

**Methodology**\* - The methodology or theoretical approach to be employed, analysis strategies and data sovereignty considerations. **Timeline** - The time period within which the work will be undertaken.

## **Knowledge Mobilization and Anticipated Outcomes 1/1**

There should be a clear indication of the expected outcome(s) of the proposed SRC activity (e.g., publications, presentations, student training, preliminary stage of a large project, community engagement initiatives/outreach, etc.), including where appropriate, how the proposed SRC activity will prepare the applicant for future externally funded applications.
