1. **President's Report**: The President commented that it was hoped that the Senate meeting did not go long given the interest in the US election.

President Levy reported on the fiscal situation. The operating budget of the University is made up of half tuition fees and half grants. Tuition fees are set under the last year of the policy that limits annual tuition raises to 5%. There is little information from the government on operating grants. There is a good estimate of expenses for next year, and a number of universities have agreed that it is prudent to slow down on new academic appointments to avoid being accused of not being able to afford them later. Those who wish the University to take more risk in these hires should realize that the risk will fall on the most vulnerable in the community. Ryerson's operating budget is one of the strongest in the system. We have low exposure on endowments because we do not have that many. Those which support student bursaries and scholarships will be honoured. Ryerson's pension is a defined benefit plan, and therefore the current financial situation has no effect on anyone's pension. Other institutions with defined contribution plans have a problem as those who wished to retire may no longer be able to do so. Ryerson's pension is very strong and as long as the market turns upward in the next few years, the pension will remain strong. Enrollments remain strong. It was asked about the implications of the financial situation on the construction of new buildings. The President replied that the money was already in the budget for the gallery and the Student Learning Centre.
