- 7.1 Report of the President

- 7.1.1 President's Update

President Levy welcomed Janice Winton, Interim Vice President, Administration and Finance to Senate.

The President made a short presentation regarding applications to universities by secondary school students in 2015 vs. 2014, which show that Ryerson is doing very well in that area, especially in the category of first-choice applications. He noted that, system-wide, we are going through a demographic decline in the number of secondary school students, which will be a challenge for universities in the next few years but, again, Ryerson is in a strong position compared to many other universities.

The President invited Nancy Walton to update Senate regarding Ryerson's applications for MTCU funding of online courses and modules, seven of which were successful, for a total of about \$372,000 out of about \$5.5 million across the province. She thanked the many people who worked on the applications, including from the Digital Education Strategies Team at the Chang School, the Digital Media Projects office, and the Learning and Teaching Office. She noted that there will be another call for applications in Fall 2015, so that applications that were not successful in this competition will have another chance for funding.

7.4.1 Report #W2015-1 of the Academic Governance and Policy Committee (AGPC)

7.4.1.1 Update on the October 2013 Senate motion for AGPC to develop policy clarifying the eligibility of (Academic) Directors, who are not Directors of a School, to hold faculty positions on Senate: J. Turtle

Motion: *That Senate approve that faculty who are Full (vs. Associate) Members of the Ryerson Faculty Association (RFA), including (Academic) Directors who are not Directors of a School, be eligible to serve in faculty positions on Senate for which they are otherwise qualified.*

D. Mason moved; S. Dolgoy seconded

D. Mason noted that the wording might unintentionally bar Directors of a School from serving on Senate; the Secretary noted that that is not the intent and that Directors of Schools have designated positions on Senate.

D. Checkland suggested a wording change to address D. Mason's point; a final version of the motion will be determined and brought to Senate for information.

7.4.2 Update from the Policy 60 Review Committee: D. Checkland and C. Evans

D. Checkland stated that the proposed policy revision will be presented to Senate for discussion at either the March or April meeting, and then brought for approval at either the April or May meeting. He described one important new aspect of the proposed policy revision, which is that faculty members would have the option to "hand off" a suspicion of academic misconduct to a member of a group of Designated Decision Makers (DDMs), and that a call for faculty members to express their interest in serving on the group of DDMs will go out in Winter 2015, so that they can be trained and in place for Fall 2015.

M. Dionne congratulated the excellent work of the Policy 60 review committee and suggested that it serve as an example for future policy review committees.

M. Dionne asked how the clause regarding a minimum number of members will be implemented in the Digital Media and Social Work GPC bylaws, and suggested that the wording from the TRSM bylaws be used as a guide.

Motion to Divide: *That the Digital Media and Social Work bylaws be severed from the list of bylaws contained in this motion.*

Returning to the original motion on the table, now with the GPC bylaws from Digital Media and Social Work removed, M. Dionne proposed a friendly amendment that Article 4.6 in the Nutrition Communication GPC bylaws be deleted because it was apparently included in error, to which no disagreement was expressed. Regarding the GPC bylaws for Film and Photographic Preservation, M. Dionne raised issues regarding Articles 4.4, 4.6 and 6.4, which the Chair interpreted as commentary to be taken under advisement.
