

What is advising?

Meet Your Professors

- You will be in larger classes, with perhaps less interaction with the instructor than in college.
 - Need to follow up on a concept learned in class?
 - Trying to understand the course material or how you were graded?
- Contact your professor via email to set up an appointment during their office hours.
 - Be courteous and respectful. Avoid “**Yo Prof!**”
- Problem with a professor?
 - Try addressing your concerns directly with them.
 - Still unresolved? Speak with the Student Advisor for your program.



Transfer Credits

You are eligible to apply for [Transfer Credits](#) for any courses in the Direct Entry curriculum.

Apply for:

- 5th, 6th, 7th, 8th Semester courses
- Reachback courses listed on your offer of admission

Transfer Credits and Reachbacks

- [Transfer credits](#) are granted to direct entry students on a case by case basis, pending the curriculum mirroring or reflecting the curriculum we offer.
- Typically, for Liberal or Open Elective related courses.
- If you have taken equivalents of the required reachback courses outlined in your offer of admissions, you may also [apply for transfer credits](#) for those.
- The maximum number of transfer credits for direct entry students is 5, or the less, depending on the number of [reachback courses](#) you are assigned in your offer of admission.
- Reachback courses are essentially courses from the first two years of the program that are deemed unsatisfied based on the evaluation of your application and upon receipt of an offer of admissions.

Minors

- You can explore a supplemental area of study through your elective courses and planning them in a way that helps the pursuit of a minor
- Minors consist of **6 (six)** single semester courses
 - Some courses found on the [Minors](#) curriculum, such as [Finance](#) or [Professional Communication](#), have courses that Direct Entry Students are exempt from. Visit the calendar and contact your Advisor if you have questions
- The [list of minors and their policies](#) is your guide to the minors
- Students only declare their minor(s) after they [apply to graduate](#)
- If a course is required for a minor and also in Year 1 or 2 of Business Management, DE students are exempt. However, this does not apply to reachback courses

Enrolment Periods

Full-time Direct Entry Students can choose:

- Undergraduate courses starting on **August 9th, 2022**
- Evening courses through the Chang School

Part-time Direct Entry Students can choose:

- Evening courses through the Chang School
- Undergraduate courses starting on **August 22nd, 2022**
- Limited to a maximum total of 3 courses per term (no exceptions)

Change your schedule from August 9 until September 16, which is the last day to add, swap and drop classes for a full refund

Important Dates: dropping, tuition, and refunds

- Pay attention to how you are doing in your classes!
 - You can drop a course without academic penalty up until a certain date.
Last Day to Drop a Fall Course (No Refund of Fees & no academic penalty) is **Friday, November 18th, 2022**
- Last Day to Pay Fall Undergraduate Tuition Fees
 - **Friday, September 16th, 2022**
- Last day to Drop a Course In Drop Period for a Full Refund
 - **Friday, September 16th, 2022**

Policy #46: Academic Standings

- **Clear:** Your Cumulative Grade Point Average (CGPA) is at least 1.67
- **Probationary:** Assigned when the CGPA falls below 1.67. A probationary contract must be signed and the course load is limited. Students must attend the Back in Business program
- **Required to Withdraw (RTW) for 12 months:** If the Term Grade Point Average (TGPA) falls below 1.67 while on probation or if your CGPA goes below 1.00 at any time
- **Permanent Program Withdrawal:** If you are RTW for a second time, or fail a required program course 3 times
