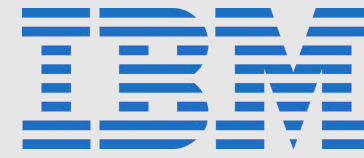

CO-OP ELIGIBILITY AND APPLICATION PROCESS

As an Economics and Management Science student, you will apply to co-op at the end of your 2nd year of studies, by **June 1st**.

Your application will consist of:

- Resume and Cover Letter
- Video Interview
- Unofficial Transcript



Please note that you do **NOT** have to complete the co-op bootcamp requirements in order to apply to co-op.

The expected CGPA requirement for Economics Co-op is 2.8.

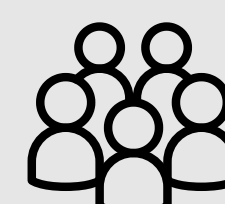

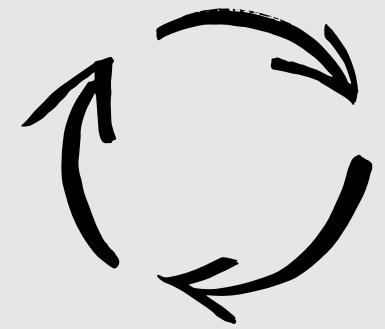
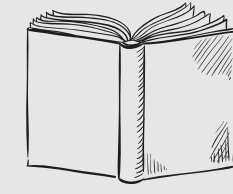

\$3,500

The co-op fee of \$3,500 is a service fee associated with the co-op program. The fee is not tied to your work terms, and is charged in installments every Fall and Winter semester after your acceptance into co-op until the fee has been paid off.
