Madam Meifang Zhang, Deputy Consul-General of the Chinese Consulate General in Toronto, served as Director for the Department of International Organizations and Conferences and the Department of External Security Affairs, and acted as Special Assistant to the Chinese Former Vice Premier and Minister of Foreign Affairs on the High-Level Panel Reform of the United Nations. She was also First Secretary, Chinese Embassy in Paris (2001-2004), and First Secretary, Chinese Permanent Mission to the United Nations, New York (1997-2001). Madam Zhang received her Master of Philosophy at the University of Cambridge, United Kingdom, and was a Senior Visiting Scholar at The John Hopkins University, United States.
